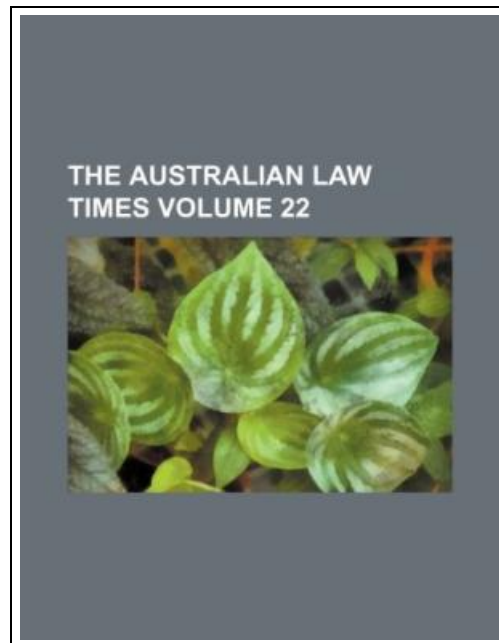

Not illustrated. 1901 Excerpt: .were paid, including all moneys received on behalf of the said trustees, and a separate banking account was opened by the firm, called the office account, into which the private moneys of the firm were paid. Cheques were sometimes drawn on the trust account for office expenses, e.g., to pay office expenses and salaries, and the office account in the firm 5 ledgers was debited therewith, and at a future date cheques were drawn on the office account, and paid to the trust account to refund certain of the moneys so used. The total amount so debited to the office account for the period 1st July, 1896, to 25th April, 1899 was 4,968, and the total amount so refunded during the same period was 750, leaving a balance owing by the office account to the trust account of 4,218. Interest on moneys supposed to have been invested by the firm on behalf of various clients was paid to those clients out of the trust account in cases where no investments were really in existence, and where no interest was actually collected, thereby reducing the amount which should have been to the credit of the trust account by the amount so paid or misappropriated. The deficiency for the period 1st July, 1896, to 25th April, 1899, was at least 20,000. On the 8th November, 1881, Mrs. S. A. Splatt was advanced by Taylor, Buckland and Gates the sum of 100, out of the 1,500 held by the...
