

1.1 Background The report was prepared in response to section 1211(d) of the Tax Reform Act of 1986 (1986 Act). That provision directs the Secretary of the Treasury or his delegate to conduct a study of the longstanding sales source rules and to submit the findings in a report, together with such recommendations as he may deem advisable, to the Committee on Ways and Means of the House of Representatives and the Committee on Finance of the Senate. The Conference Report to the 1986 Act states that the study should be done in light of the 1986 Act s lower income tax rates and Congressional trade concerns. The sales source rules determine when income from a sale of inventory property can be considered to arise within the United States and when it can be considered to arise abroad. The rules allow a U.S. taxpayer, in certain cases, to treat a substantial portion of the income from the sale of exports as arising from sources outside the United States based on a formula that gives equal weight to the place where the exporter passes title to its product and the location of the exporter s assets. Income from export sales often attracts little or no foreign...
