

On this day must be taken all subjects which could not be taken by the whole class on previous dates because of conflicts. No more than three hours shall be allowed for an examination, and no examination shall be divided, nor shall any pupil be allowed extra time, a second trial, or to take the examination at any other time than that at which the class takes it.
