We recommended FMCSA: 1) use additional motor carrier inspectors during all border crossing operating hours; 2) complete safety reviews before granting Mexican motor carriers conditional operating authority and inspect all long-haul commercial vehicles and drivers before or as they enter the United States; 3) act against those carriers which do not comply with safety regulations; 4) obtain land at border crossings to conduct inspections and place vehicles out of service; 5) revise proposed rulemakings on application procedures and a monitoring system; and 6) conduct workshops and outreach sessions to provide guidance and facilitate application processing.
