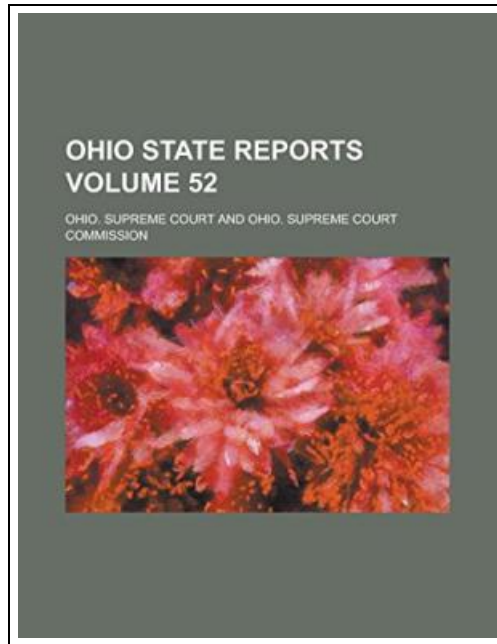

A. Sudbeck heirs, and H. W.
