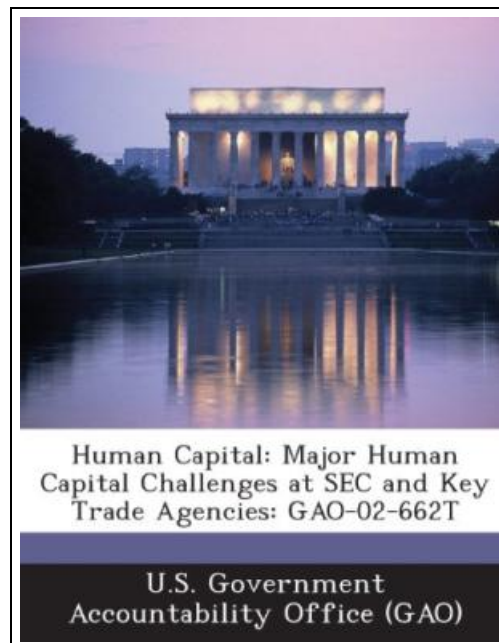

At the same time SECs workload is growing at a rate much faster than staffing. Workload and staffing imbalances have affected most aspects of SECs regulatory and supervisory activities, from its inhouse technological capabilities to its enforcement actions against market participants. Other agencies that monitor U. S. trade agreements also face human capital challenges. Since the early 1980s, the United States has entered into several hundred trade agreements that have dramatically increased monitoring and enforcement workloads at USTR, Commerce, and Agriculture. This workload has continued to grow during the past two years as a result of major multilateral, regional, and bilateral trade negotiations. These agencies efforts to monitor and enforce trade agreements are hampered by a lack of sufficient staff with appropriate expertise.
