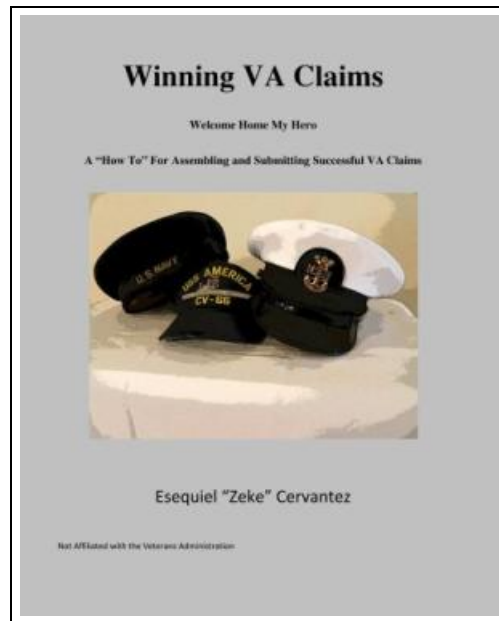

It offers advice to always use free resources such as the well trained Veteran Service Officers that have been trained to assist and represent the Veteran. It will additionally offer hints along the way to ensure the Veteran does not make common mistakes (especially at Compensation and Pension Examinations) that slow the claims through the adjudication process or may end in denial. It does not contain all the trials, tribulations and moments of claim success that the Author has gone through. The Author specifically designed the booklet be informative, inexpensive and wrote it to only contain pertinent VA Claim and appeals process information. Diagrams for the Appeals Processes have been included, but the Author believes that the Veteran needs to concentrate on ensuring that the claim goes through the adjudication process correctly the first time so that it minimizes the need for the Appeals Processes (since it also add considerable amount of time to resolve a claim). Some of the claims that the Author has reviewed with several Veterans indicate that the reason for their claim denial results comes down to the claim missing required elements (in Author s formula) or poor performance during a compensation and pension examination. He provides the information, methodology and hints to successfully transverse the adjudications processes. Also included are hints to ensure that the Veteran has the tools that can be used to ensure that they have the same records and evidence that the VA has in...
